## "Phillips Inn" To Be "Andover Inn"

"Phillips Inn" became "Andover Inn" on Monday when the management of the well-known hostelry on Chapel avenue was taken over by the Treadway hotel interests, following the retirement of John Stewart after a long period of service. The Trustees of the Academy still hold the title to the property, but the operation of the Inn has been turned over to the Treadway group of hotels.

The new manager, George M. Brakey, is planning to change more than the name. The fundamental change will be in the atmosphere of the Inn which he desires to make less formal, more home-like. Some renovating and refurnishing will be done. There will also be a change in rates for both meals and rooms, the minimum in both cases to be less than heretofore.

Mr. Brakey has been six years with the Treadway group, and more recently has been at the White Hart Inn at Salisbury, Conn. Assisting in the changes at present is Mr. Jones, manager of the Treadway-operated Lord Jeffery Inn at Amherst. Mrs. Brakey is to be hostess.

## Finis Written To Bank Night Controversy

District Attorney Hugh A. Cregg stated this morning that he "has no further interest" in the Andover Playhouse Bank Night controversy "unless it is shown to him that there is a violation of the law." He said that from what he was able to learn, there is no violation and therefore he would not stop Bank Night.

Last night Paul A. L'Antigua, who submitted the complaint to the District Attorney, announced that he too, after hearing manager Samuel Resnik's side of the story, was convinced that the practice is within the law. The Supreme Court

handed down a decision last week which in effect stated that bank night could not be ruled a lottery per se, the methods of operation being the important factor.

The District Attorney had detective Richard Griffin make an investigation of the L'Antigua charges, and the preliminary report revealed no law violation. He said that the worst-sounding charges fell down under examination. Interested in the complaint that dead men's names were called, he learned that this had been done in one instance, but it was "not deliberate, but unfortunate," and therefore not a law violation.

## Adult Courses To Start Monday

The Andover Evening Study Groups for adults will open next Monday night, with registration still possible in a number of courses. Cards are being mailed out to all those who have registered to date and will reach them in time for the courses.

Courses closed to date are: Studio Art, except for rapid figure sketching; Photography 1 and 2; Effective Speaking 1; and Recreation for Women. Effective Speaking 2 is similar to Effective Speaking 1 and may be still entered.

## Intentions, Deaths Jumped In 1939

Both marriage intentions and deaths took a decided jump in Andover the past year. Marriage intentions, which totalled 97 a year ago, reached the figure of 128 this year.

Death, however, took a heavier toll by 25. In 1938 there were 137 deaths, with 162 being reported as the total for 1939.

Figures are not yet available on births and marriages since more certificates are expected.

Rev. Newman Matthews read resolutions on the death of all members of the church during 1939.

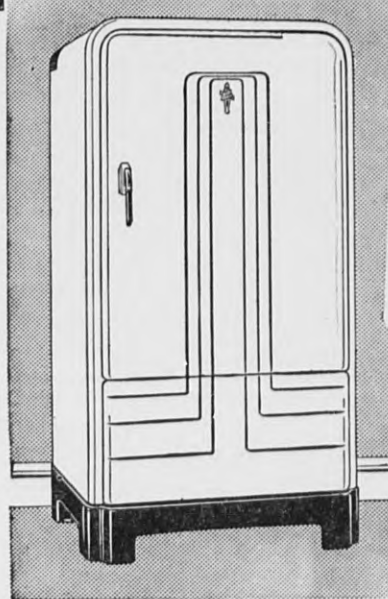

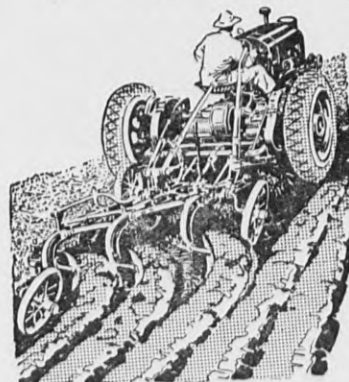

# EDITORIAL

## Election's Coming

Going to run for office? Oh, you don't want to. Takes too much time? You don't get anything for it except hard knocks?

You're right. If you're going to run, you'd better make up your mind now that you should be willing to give as much time as possible to the office if elected. And if you're thin-skinned, you'd better not run. But if you have a real desire to see town government run efficiently, it might be well for you to develop a thicker skin. For if everybody capable of holding town office the way it should be held felt that he shouldn't demean himself by running for that office, it would leave a rather sorry lot to whom we would be entrusting the management of a very important business.

Look through the list of town officers whose terms expire this March. If there are some on that list who don't care to run again, do everything you can to find a good candidate for that position. If there are some on the list who shouldn't run again, find somebody who can beat the undesirables. And how about running yourself?

Let's make the town ballot something which will present a list of desirable names to the voters, not something from which they'd have to choose the least of several evils.

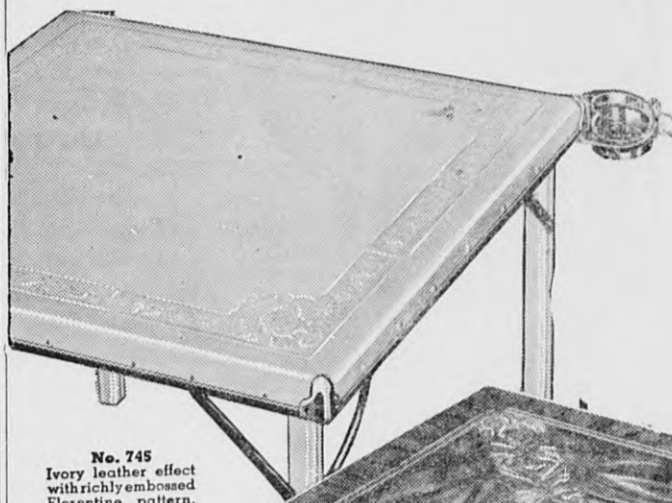

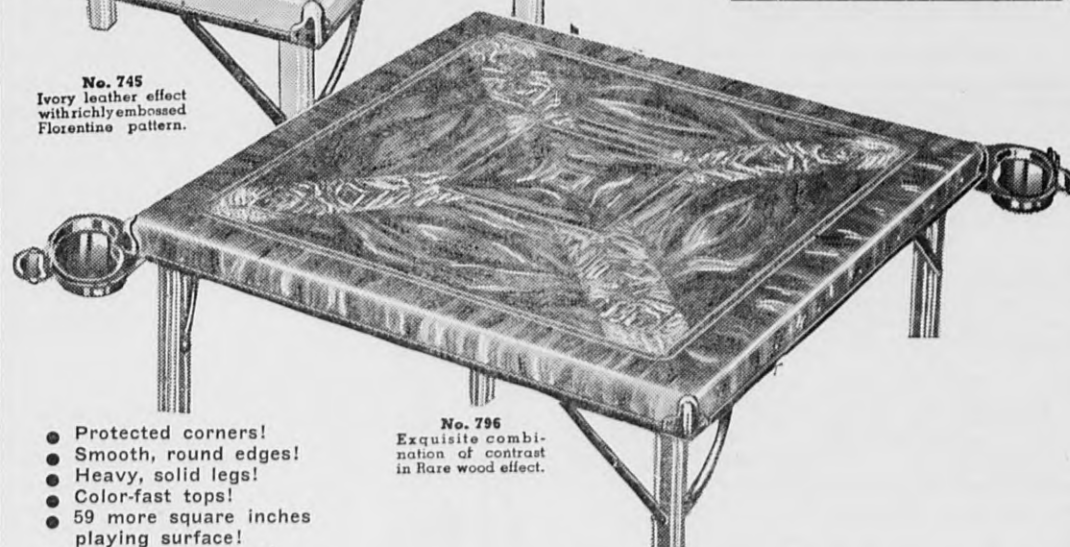
