## Phones To Remain In Status Quo

Another "Finis" has been written to the telephone toll question. The Department of Public Utilities, apparently basing its decision on its own poll rather than the privately conducted poll, turned down petitions for an abolition of toll charges, this being the fourth time in the past fifteen years.

The commission reported that the telephone company expressed itself as willing to supply the type of service that the majority of people in Andover wanted, but the commission's poll showed that a majority desired the present set-up.

The seven-page report of the commission went over the case in detail, and then explained the reason for toll charges: toll service being a service used by a minority in the exchange, a special service and as such one which should be paid for only by those using it. "If special services of any type are not charged for in accordance with the cost of maintaining such services, then the minority would eventually benefit at the cost of the majority." In the Andover case, as shown by the poll, "it is the minority who would have been the recipients of the benefits of a change," the commission concluded.

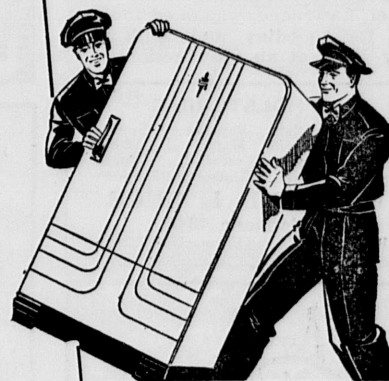

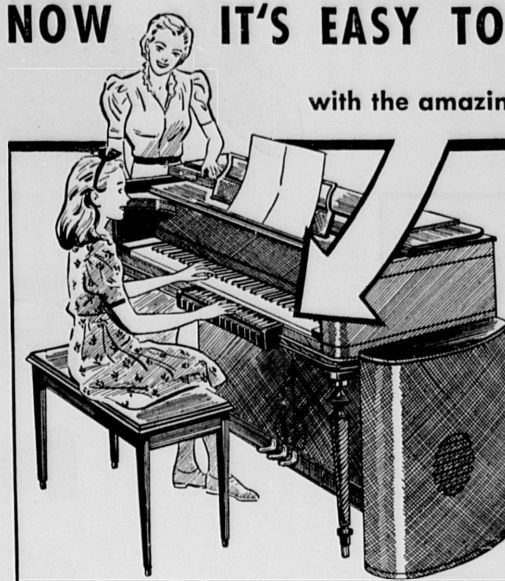

### Shawsheen Annexed By Lawrence?

One of those ideas which come forth every once in a while from the Lord only knows where came forth the past week when it was suggested, apparently as an aftermath of the telephone toll charge elimination defeat, that Lawrence should annex Shawsheen!

The article which made this suggestion stated: "Shawsheen was a gift to Andover." Historically and every way else that statement is off. Shawsheen was Frye village, and Frye village was a pretty nice piece of old Andover, as nice a piece of old Andover as Shawsheen is a piece of new Andover. Certainly because a section of a town is developed into a beautiful model village is no reason why another city should annex it. Furthermore, who gave Shawsheen to Andover, if it was a gift? Certainly not Lawrence, for a goodly part of Lawrence used to be part of Andover, and not vice versa.

"Geographically it is as much a part of Lawrence as of Andover," the article continued! Sounds just a bit like Hitler's protective custody or desire for lebensraum coming on. To grant that reasoning would be to permit of further annexations so that Andover would no longer be Andover. Well, from what we read and hear, it would be better to vote blindly for an Andover candidate than to vote with your eyes wide open for a Lawrence candidate. We don't believe, either, that the majority of Lawrence's voters know the persons for whom they're voting; we refuse to believe that of Lawrence's voters.

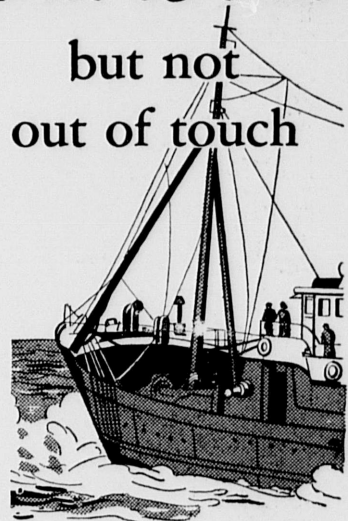

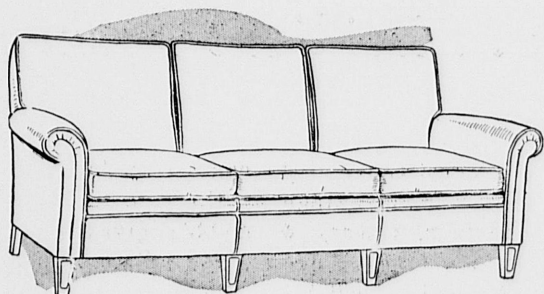

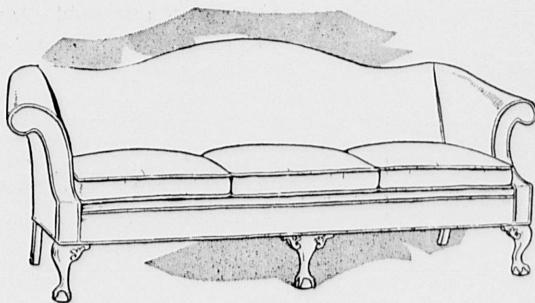
