## What's Wrong?

What's the matter with Andover What's wrong with its town gov ernment?

Everybody knows. Everybody has a solution. It's talked over in the living-rooms of our Andover homes: it's talked over on the street corners. And the persons who do the talking really know, and are very positive of their facts and their opinions. There's no room for doubt
Well, what IS the matter with Andover?
If you go deep enough into this problem, you'll find that there's really one basic trouble with Andover, and that is that everybody does know and does talk it over in the living-rooms and street corners, but nobody does anythng about it where it would do any good. It really boils down into a lack of courage, an apparent willingness to be a big shot in your little group of friends but a terrifying modesty when it comes to saying anything in the places where saying some thing might do some good.
Where are those places? Of course the final place of judgment in Andover in most things is the annual town meeting. You notice that every year it's the same few persons who do the talking, some of them sensible, some of them not.

Another place where public expression of opinion might crystamme patio opinion is in the comminication column of the Townsman, try putting your thoughts in writing, and we'll put them in print
Don't be so modest, Andoverites. If your opinions are good enough to be inflicted upon your friends every Saturday night, they are good enough to be brought out who bore your friends?
