Gil Dodds To Run At P. A. Saturday

Gil Dodds, who has run the mile in 4:06.1, is coming to Andover on Saturday afternoon to demonstrate his running abilities in connection with the Fifth annual New England Prep school meet on Brothers' Field. Dodds is scheduled to run about 4 p. m. In the Interscholastic meet the weights will start at one and the running events at two. There is no admission charge.

Dodds is the present holder of the world's indoor record for the mile. In 1940 he won the National Collegiate association's four-mile run across country while at Ashford college, Ohio. Later he went to Boston College, training under Jack Ryder, and two years ago he entered the Gordon Seminary. He then became the outstanding miler of 1942. Last summer he toured the country with Gunder Hagg.

Punchard Graduates Succeed in College

Records of twenty-two Punchard graduates, attending fifteen universities and colleges throughout the country, have been obtained. Massachusetts Institute of Technology, Radcliffe, Simmons, Boston University, Tufts, University of Michigan, and University of Wisconsin were among the institutions sending reports of former students.

A total of 397 grades in major subjects have been received up to date. These are: 81 A's (90% - 100%), 172 B's (80% - 90%), 123 C's (70% - 80%), 20 D's (60% - 70%), and 1 failure. These reports show that 63.7% of the grades obtained are B's or better, 31% C's, 5% D's, and ¼ of 1% F's.

English is a basic subject in high school and college. Seventy-four per cent of the English grades obtained are B's or higher and only 7% are D's. In Mathematics, 50% of the grades are B's or higher and only 3% are D's. There were no failures in either subject.

SERVICE CLUB SCHOLARSHIP AVAILABLE

The Andover Service Club, through the chairman of its Vocational Committee, Edward I. Erickson, announces that another scholarship loan is available for this year. Candidates may apply now to the Chairman of the Vocational Committee.

The scholarship loan amounts to \$100. Repayment is not expected until one year after the completion of the student's course. Candidates who are undertaking vocational training are preferred; but in the absence of such applicants, students entering or attending liberal arts colleges are acceptable.

Church To Conduct Impressive Service For Servicemen

On Sunday night at 7:30 in the Free church a service will be held to honor the more than one hundred and fifty boys and girls of the Parish who now serve their country in all parts of the earth.

Ivar Sjostrom, church organist, will conduct a "request" recital for a major portion of the service. Men and women in the church, as well as servicemen and women, have been invited to send their requests to him in order that he may include them in the program.

At the conclusion of the recital, a short but impressive testimonial to servicemen and women will take place. A huge birthday cake, surrounded by more than one hundred and fifty candles, will occupy the center of attention. The minister will read the names of all those serving their country and as each name is read a candle will be lit. Two candles on the cake will represent the two young men who have made the supreme sacrifice. A brief prayer and benediction will conclude the service.

Immediately following this service the families of servicemen and women will be honored at a reception in the Parish House. An invitation has been sent to all members and friends of the Free church, including servicemen's families. The service is open to the public and the doors will be open at seven o'clock.

River Exercises Will Be Omitted

There will be no memorial exercises this year by the Ladies' auxiliary to Sons of Union Veterans, customarily held each year at Marland bridge over the Shawsheen river. Mrs. Henry S. Wright, last president of the unit, has announced that the organization has disbanded.

For two generations the familiar program has been a part of the annual Memorial Day program, being held on the Sunday preceding the holiday, and this is the first year that an official delegation from one of the Civil War units will be omitted.

Largest Tin Can Collection To Date

Andover's tin can collection held last Sunday netted 17,025 pounds and was the largest total in any one collection held to date.

Under the direction of Supt. Charles Gilliard of the B.P.W., local volunteer truck owners started out at 1 p. m. and were assisted by 30 boys from the Andover Junior High School.

High Wind Fans Forest Blazes

Andover was again threatened with a series of forest fires Thursday morning when a high wind fanned two blazes which broke out within a short time of each other, one on Vine street and the other on Lovejoy road.

The Vine street blaze, responsible for the sounding of Box 341, was near the home of P. W. Moody, and was fortunately checked before it reached the dwelling. Part of the lawn was burned, and a wooded area nearby was badly damaged, a large number of evergreens going up in flames.

While at this fire, the department was notified of the blaze on Lovejoy road. It went deep into the woods, traveling in the direction of Dascomb road. The all-out was sounded at 12:45.

Free Church Fair Planned for October

The annual Fall Fair of the Free church is scheduled to be held October 5 and 6, afternoon and evening of both days. The Wilson Club, the church's mens' organization, will have charge of the supper to be given on the second day of the Fair.

In preparation for the Fair the Parish has been divided into thirty-two districts with a Chairman in charge of each district. Monthly collections will be made at parishioners' homes of items designated for each month. May is Apron month, June is Handkerchief month, July, White Elephant, August, Preserves, September, Fancy work.

A Fair Executive Committee is being set up, and various church organizations and societies are being assigned responsibilities in connection with this Fall event. It is the hope of church officials that everyone of the more than four hundred families in the Parish will be actively participating during the coming months in the program of Fair preparation.

Association Plans Memorial Service

A memorial Service is planned by the Servicemen's Fund Association on Sunday, May 28, at 8 p. m. in the Memorial Auditorium. The speaker is to be Rev. Martin W. Stackpole, formerly at Phillips Academy and now minister at Milton Academy. He was also chaplain of the 102nd Field Artillery during the First World War and there were many Andover boys in this particular outfit.

The singing will be under the direction of J. Everett Collins.

Local Postmaster Retires on July 1st

Senator Walsh to Name New Official

Postmaster John H. McDonald will retire on July first, having reached the retirement age of 70. Mr. McDonald has been postmaster since 1933, having been appointed shortly after the Roosevelt administration took over. He had also served during the Wilson administration, his initial appointment having been in 1914.

An acting postmaster will be appointed when Mr. McDonald's retirement becomes effective. Later an examination for postmaster will be held, the date for which has not yet been set. It is understood that the appointment will probably be up to Senator David I. Walsh. Ordinarily the Congressman in the district has the patronage privilege in this case, but Andover is now in Mrs. Edith Nourse Rogers' district, and since she is a Republican and the administration Democratic, Senator Walsh, a Democrat, will probably be given the privilege of naming the new postmaster. The other Senator, Mr. Weeks, is also Republican.

Ruth Ann Chadwick, winner of the first prize in her grade for the third year in a row, finally emerged the victor in a half-hour contest with Robert Gagne, also a previous winner. Both youngsters are in the seventh grade of the Junior High School.

Other children who had won before included: William Stopford, first prize winner in the finals, who also won first prize last year in the eighth grade; Donald Mulvey, who took first prize in his grade last year; Marion White, third place winner this year, was the first prize winner in the fifth, sixth, and seventh grades. Marilyn McKay, who placed second this year, also won second prize in her grade two years ago. Brenda Giles, first prize winner of the eighth grade, won second place when she was in the fifth grade three years ago.

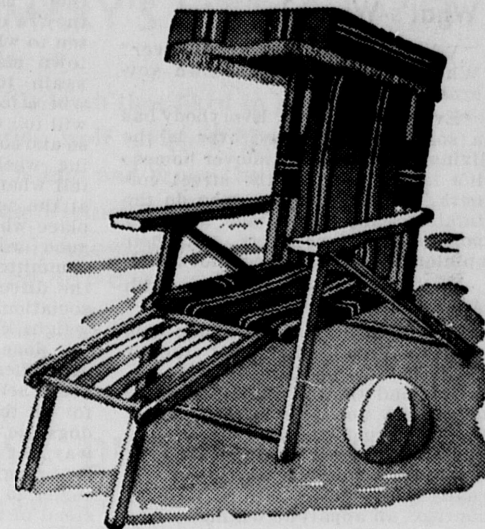

Editorials



What's Wrong?

What's the matter with Andover? What's wrong with its town government?

Everybody knows. Everybody has a solution. It's talked over in the living-rooms of our Andover homes: it's talked over on the street corners. And the persons who do the talking really know, and are very positive of their facts and their opinions. There's no room for doubt.

Well, what IS the matter with Andover?

If you go deep enough into this problem, you'll find that there's really one basic trouble with Andover, and that is that everybody does know and does talk it over in the living-rooms and street corners, but nobody does anything about it where it would do any good. It really boils down into a lack of courage, an apparent willingness to be a big shot in your little group of friends but a terrifying modesty when it comes to saying anything in the places where saying something might do some good.

Where are those places? Of course the final place of judgment in Andover in most things is the annual town meeting. You notice that every year it's the same few persons who do the talking, some of them sensible, some of them not. The living-room experts have said

their say in the living-rooms; they're content to sit back and listen to what these few people say at town meeting, and then to retire again to the comfortable chairs where for the next few weeks they will tell what they think about what so-and-so said and for the remaining weeks of the year they will tell what they think should be said at the next town meeting. Another place where talking might do some good would be with the finance committee, the town officials, and the directors of the Taxpayers' association. If your opinions have any weight, chances are something will be done; if your opinions are groundless, you'll be told why they are. There is a tendency, of course, for all these groups to let sleeping dogs lie, because it's easier that way, but if sufficient public opinion is brought to bear, it might be easier to heed the barking dogs instead of the sleeping ones. Another place where public expression of opinion might crystallize public opinion is in the communication column of the Townsman; try putting your thoughts in writing, and we'll put them in print.

Don't be so modest, Andoverites. If your opinions are good enough to be inflicted upon your friends every Saturday night, they are good enough to be brought out into the open. If they're not—well, why bore your friends?

This Sober Town

Even back in the days of early 1932, when pretty nearly every bank in the United States experienced a run, the Andover National Bank remained with the faith of its depositors unshaken. There was no run on our local bank. But times have changed and a couple of days this week, Mr. Holland and the directors almost had to decide to close the doors to stop the hordes of persons indulging in an honest-to-goodness run on the bank.

It was a historic moment in the history of the United States, for it symbolized the end of the era in which we really did feel that we'd need stirrup pumps to put out the fires caused by incendiaries from German planes. Mr. Holland is local property custodian for the United States, and down in the bank cellar there were several hundred stirrup pumps, with no place to go. It's a bank's business to loan, and so that's what finally happened. There was no public announcement, but the rumor spread like wildfire that you could go to the National Bank, sign a slip of paper printed by the Townsman Press (advt.) and walk off with a nice big galvanized stirrup pump in your arms and in your possession. Finally it was decided to stop the loaning for that day, and then word got around that another 500 would be released when the bank opened the next morning. Persons who arrived at 9:15 were just out of luck; it was too late!

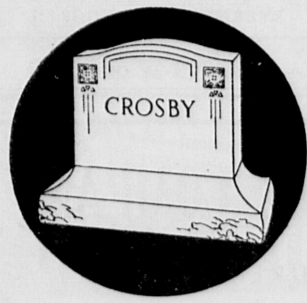
To her tribute was added a word of appreciation for the work being done by the Sisters of Notre Dame, who teach in St. Augustine's school.
