Shawsheen Homes Are Entered and Looted

A matter of concern to Shawsheen residents is the report this week of three more house breaks over the weekend, which brings the total to five this month. The culprits have followed the same procedure in all the homes entered, the curtains being drawn and the ransacking done apparently at their leisure.

Frederick McKay, 5 Arundel street, reported to the police that his home had been entered and cigarettes taken. A number of War Bonds were left untouched, though a search had obviously been made for money.

More serious losses were suffered by Francis R. Rody, 28 Enmore street, and Raymond Howe, 19 Arundel street. The former lost \$135 and the latter approximately \$100, while an even larger sum of money was overlooked here also.

Police Chief Dane has questioned a number of young boys suspected of the breaks, meantime warning householders not to leave doors unlocked, especially in homes where no lights are left burning.

Parents have been warned by Police Chief Dane that streets set aside for coasting should be used by the children of the town as an added measure of protection against serious accidents. There have been complaints that youngsters are sliding down embankments onto streets as well as coasting after dark. Streets set aside for coasting are as follows: Morton street, Marland street, Ballardvale; Bartlet street and Red Spring Road.

Local Soldier Offers Post-War Plan for U. S. Foreign Policy

Sgt. Karl Haartz, local man located at Camp Clayburn, La., has submitted a discussion on post-war peace planning and subsequent U.S. foreign policy. Contrary to popular belief, some of our fighting men at least, are not in favor of a hard peace, but one rather that will insure lasting results for the good of many, rather than inflicting hardship in retribution to a few.

Elements Affecting the War of Decision's Peace

Experience can lead us astray. Therefore, consideration should be given to the set of conditions which will exist in Europe at the end of this war, as compared to those conditions existing at the end of the last war. In reality, a substantial difference will prevail. The last time there was in Europe no power capable of keeping the peace. But this time, there is already present a great and sufficient power, Russia, which is ready, willing and able to keep the European peace, the same as the United States keeps the peace of the Western Hemisphere.

And now is a time to remember well that, because one course of action was wrong, it does not follow that the opposite must be correct. Consequently, our continued intervention in Europe, which may

Local Man Reported Missing for 2nd Time

Mr. and Mrs. Edward J. O'Hagan of 1 Baker lane have received word for the second time that their youngest son, Peter, is missing in action.

He was reported missing in France some months ago, but later it developed that he had been captured at Brest and returned to his unit when that city fell. His parents received word on Monday night that he is a casualty of the German front.

Fire Department Reorganized Following Drowning Tragedy

The anticipated shake-up in the Andover Fire Department came this week when Deputy Fire Chief Lester Hilton resigned and Alexander MacKenzie was given a thirty-day suspension, as a result of the recent drowning tragedy in Ballardvale.

Deputy Chief Hilton submitted his resignation Tuesday morning, and it was later accepted by Fire Chief Buchan effective the same day. Lt. Albert Cole was made Acting Deputy Chief and Kerr Sparks

was made Acting Lieutenant. Charles Murnane, a military substitute, was appointed to the vacancy caused by the resignation, and a new military substitute will have to be appointed. All these appointments are subject to Civil Service Commission approval. The Civil Service examination will have to be held for the permanent appointment to Deputy Chief.

The resignation and suspension closed the case as far as further disciplinary action was concerned. Chairman Roy E. Hardy of the Board of Selectmen is now preparing an extensive report on the whole matter and its various recommendations will be available very shortly. The recommendations, Chairman Hardy stated, will have nothing further of a disciplinary nature, and will probably deal mostly with the need for closer cooperation between the two public safety departments.

The extensive investigation conducted by Chief Buchan following the tragedy culminated in a hearing Saturday at the Town House presided over by Town Counsel Walter C. Tomlinson. All those who had a close connection with the affair were present and were asked a great many questions by the Town Counsel. There had been quite a bit of confusion about the number of telephone calls that had been made, but apparently the correct story was finally pieced together. As a result, Fireman Howard Colbath of the Ballardvale station was entirely cleared of any charges. Chief Buchan stated that testimony showed that two calls had been made to the central station by Colbath, and on the first of these calls, he was told to stay in the station because the case was being handled by the Police Department.

Lt. Lionel Boisvert Fatally Wounded

Second Lieutenant Lionel Arsene Boisvert died December 14 at the McGuire General hospital, Richmond, Va., as a result of wounds received during Army maneuvers a few hours earlier.

Lieut. Boisvert has been in the service since Jan. 1940, and was awarded his commission in March, 1943, following his graduation from the chemical warfare school at Edgewood Arsenal. Later he served as an instructor at Camp Swift, Texas.

Before entering the Army he was employed at the Wood mill. He married the former Crystal Lind, of Rockford, Ill., in Reno, Nev., in October, 1942.

In addition to his wife, Lieut. Boisvert is survived by a son, David; his father, Edis Boisvert, of River Road, and a sister, Claire.

His father and sister, both attended the military funeral services and burial in Rockford, Ill., on December 19.

Editor, The Townsman,
Dear Dr. Editor:

The tragic death of George Nicoll may cause shake-ups in our Public Safety department that may have been long overdue, but there is another implication in this tragedy which I should like to point out to my fellow citizens.

It is all very well to have our Police and Fire Departments geared to meet emergencies, whenever they may arise and wherever they may be, but are we not also obligated to do everything in our power to prevent such emergencies arising? I am asking for the ounce of prevention which will obviate the necessity of using a pound of cure.

Had we adequately solved the problem of community recreation, the death of this boy might not have occurred. Had we as a town provided safe, adequate skating facilities in every section of Andover within easy access of boys and girls, yes, and adults too, the chances of such a tragedy occurring would have been minimized.

Or had we as a town provided paid supervision of our recreational program, either on a full or part time basis, skating on our ponds and rivers would be taking place under the watchful eyes of men who would know how to act in the event of an emergency. As it is at the present time our emphasis in recreation comes in the summer playground and swimming program and while this work is excellently administered it involves only one season of the year.

More than a week ago the Andover Service Club voted to expand \$100 for a skating rink back of the Stowe school and this is a step in the right direction. But to expect private organizations to finance community recreation is unreasonable. They may help defray some expenses, but in the main a community must pay for its own recreational program and facilities. Andover must come to the realization that its recreational

program is not up to standard. It is not year round. It is not well coordinated. It lacks central administration.

We have more than fifteen hundred boys and girls of school age who should have recreation Fall, Winter and Spring as well as in the Summer. If we as a Community do not provide them with such a program they will find it wherever and whenever they can, and in many instances the ultimate result may be harmful to them. I am pleading for an advance to be made in Andover recreation. We need a study of our program, of our facilities, of our administration. We can prevent such tragedies by sensibly investing a small portion of our money in youth and his leisure time activities.

Today in America more than twelve hundred towns and cities have Recreational departments with full time Recreational Directors in charge. Such a step

will eventually be taken by Andover, but is there not some danger in delay? Has not George Nicoll's sacrifice focussed our eyes upon a desperate need? Some sensible steps for advancement in recreation are to be proposed at the next town meeting. There are some of us who believe that a progressive community like Andover will stand behind suggestions for improvement, and in particular where such improvement is in the interest of our youth.

NEWS OF OUR MEN AND WOMEN IN UNIFORM

Peter F. Brucato, who was a crew member on the BENHAM that won the Class A New London to Marblehead race in 1939, and who is now a Boatswain's Mate on an LST in the Southwest Pacific says: "I would venture to say that week-end cruising in small craft will be most popular after the war. I'd like to own a 40-foot cutter rig and use it for week-end sailing and summer cruises." Brucato believes that the enthusiasm and skill at sea being displayed by former farmers and urbanites is a preview of Americans who will want to continue their contact with the sea. "Once the sea gets in their blood and they find peace and happiness riding the waves, they'll never get it out," states Brucato.

PENINSULAR BASE HEAD-QUARTERS, Italy. — Sergeant Richard W. Schreiber, son of Mr. and Mrs. William Schreiber of Main street, Andover, Mass., who is serving with the G-1 (Personnel) Division of this Base, was recently promoted from Technician Fifth Grade to his present rank.

The Peninsular Base Section, in which Sgt. Schreiber is serving, is the important Service and Supply organization for Fifth Army and the ground forces of the U. S. Air Corps and Navy in the entire Italian theatre. The first military supply Base on the mainland of Europe, it has since amassed a long record of achievements including the complete rehabilitation of the once devastated Fort of Naples.

Sgt. Schreiber has been overseas since November, 1943, serving in North Africa and Italy for which he has earned the African-European Theatre of Operation Campaign Ribbon bearing two Bronze Stars for participation in the Italian campaign. He has also been awarded the Good Conduct Medal.

have been right and proper after the last war, will not at all be the necessary and wise thing at the end of this war, any more than it is necessary or wise for England and Russia to take a large and active part in maintenance of peace in the Western Hemisphere. But getting out of Europe as soon as the fire is well under control, and letting those most interested in its peace shoulder their full share of the responsibility, does not make us one whit less internationally minded in a workable manner, practical and economical. In fact, it would indicate we have put our wisdom over our emotions, as do the Russians and the English.

We all realize that where three parties are concerned, two of them tend to team up against the third. Whereas two parties get along fairly well. And the European set-up of 1945 already has two parties on hand, Russia and England. No doubt, Russia is only being practical in wanting us around as long as Lend-Lease operates for her benefit, and 1,000,000 of our men are doing her police work for nothing. England, too, wants us around so that the Russians will not become too practical with her. But, it must be realized, however wrong our policy after the last war, it does not necessarily follow that what should have been done then is the correct thing to do now. It is not.

We must remember, too, in dealing with European statesmen that it is rather easy to flatter the wool over our eyes, that it is a tendency of our country to pay too much for a joint accomplishment, and that our self-confidence leads us astray—these are our unwitting, but real liabilities. Most important of all is at least a fair comprehension that this peace, to be successful, must be concerned mostly with the correction of the faults of the last peace. The new peace must not be allowed to make the fatal and ageless error of being concerned mostly with making retribution for wrongs committed after the war got under way. For if it is, we will simply use the peace as a means by which to continue the fight, in an entirely one-sided manner. The end result of such a peace is open war again, for it never was peace.

Consequently, here is a United States foreign policy that is practical, fair, and understandable.

1. All United States armed forces shall be returned to their home stations within six months after the present war—the War of Decision—is ended.

2. The United States armed forces shall, at all times, remain sufficiently powerful, considering world conditions. These forces shall remain at their home stations except for

the same means. Therefore, it is up to Russia, whom we have helped to become powerful, and to China, whom we shall further help, to respond in sufficient amounts to their new, definite, and costly responsibilities to maintain peace in Europe and the Far East, respectively.

6. Russia is now sufficiently strong to be able to deal with all of Germany as she sees fit, having in mind her responsibility to keep the peace in Europe.

7. Since England and France, however sincere, fell far short of competently fulfilling their responsibility to European peace after the last war, they shall have to be put on probation, to prove to the world their ability to fulfill their intentions to cope with the expense and wisdom required in present international problems. This will best be accomplished by putting their own empires in order now, before taking on the additional burden of trying to run Germany too. For some time, they shall need their best minds devoted entirely to home problems, which were part of the cause of the present war.

8. The United States shall pay for its share of the neglect after the last war by cancelling all debts still due it from European countries as a direct result of that war. Out of respect to a small country, Finland, the United States shall return to Finland all the money it has paid on its debt to the United States since 1924.

9. The United States shall cancel all balances due it under Lend-Lease, which shall be terminated

not later than six months after present hostilities cease.

10. The United States expects Russia and China, after hostilities cease, to achieve and maintain peace by means other than the killing or imprisonment, or both, of people for political reasons.

Thus, the War of Decision will set off to a good start its Peace. If peace could be achieved by revenge, retribution, hate, or hard terms, the world would have become peaceful long ago. "Hard peace" advocates have been applying their principles for 6,000 years. Still we have wars. Now they insist that we again follow a policy which has failed for 6,000 years. These are forceful facts, regardless of whether they agree with our emotions. The peace cannot concern itself too much with wrongs committed once the war got under way.

This is the policy for which I fight, in this war which can be of decision.

Editorials



We Have A Lesson To Learn

Citizens of Andover have probably been saying the past few days that the members of the Fire Department have now learned their lesson, and will probably be a little more eager to do everything possible in the line of duty.

There's a real lesson, however, for the people of Andover themselves to learn. A few months ago we stated in an editorial that we hoped it wouldn't take a fire fatality to convince the town that its Fire Department was undermanned. Last winter there had been a midnight fire in a frame apartment building, and it could have been a holocaust. That fire and the recent drowning will very probably convince the town that it should grant Chief Buchan's frequently-expressed desire for extra men. It took a death to do it. Quite a few years ago, we got extra men for our Police Department. It took the murder of a policeman to convince us of the need for that.

We're not too wise in the spending and saving of our money. There are quite a few ways in which we spend money that are entirely unnecessary. Economies could be made in the running of our town government, economies which we have pointed out during the course of the past year. But it apparently takes more courage than some of our town officials and leaders have in order to get these administrative reforms under way. However, the money we waste in these very things could well have been used to provide more firemen. It is much too easy to leave things just as they are. If we waste money somewhere, it's much easier to go on wasting it than to make the necessary correction. If we're saving money somewhere, it's much easier to keep on making that saving, even if it does imperil human lives.

It happens all the time. Some citizen presents a propo-

sition at town meeting asking for \$300 to have a bad curve in a road straightened out. He usually gets scant attention, and the \$300 is not granted. Then along comes something else that costs a couple of thousand dollars, and we're quite willing to spend that because we always have. Some day that citizen who asked for the \$300 may come before a town meeting reinforced in his argument by a recent fatal accident at that bad curve he wanted eliminated, and then we'll say, "Oh, sure, we must have that." But it apparently will take a fatality to do it.

The same thing applies in the sanding of our streets. For some reason, Thursday morning even the hills, despite the fact that they were coated with glare ice, were not sanded. There were several accidents, because, as everyone knows, no matter how slowly you go on glare ice down a hill, it's almost impossible to keep control of your car. Those streets should have been sanded much earlier than they were. It shouldn't take accidents to convince the Public Works Department of this. And don't let's fool ourselves that they're trying to save us money. The men who hang around in the Public Works barns might just as well be sanding the streets, and we wouldn't have to pay them a cent more for working than we have to pay them for standing still.

Yes, there are plenty of things to be done here in Andover, plenty of precautions to be taken, and if the town, its officials, and its leaders only had courage enough to make economies where they could very well be made and to spend money where it should be spent, the young boy who went to his death in the waters of the Shawsheen might well have taught a lesson to more than the Fire Department.

A Hard Job Well Done

Chief Eddie Buchan of the Fire Department deserves the town's highest praise for the very thorough and courageous way in which he handled the recent investigation of his department. Since he became chief, he has done an excellent job, despite several very real obstacles. The way in which he tackled this very serious problem proves that the selectmen, in appointing him, made a very fine choice. It is to be hoped that his department, every member of the department, and the townspeople will get solidly in back of him so that we will have a Fire Department worthy of him and that we will have a Fire Department worthy of the town.

A Change in Policy for the Duration of the War

Since the beginning of rationing we have been confronted with many problems which by degrees have caused us to make changes in the method of conducting our business. The recent and sudden return of many food items to the ration list will mean a great hardship to everyone. To us, a service store, it will mean additional bookkeeping and record making. Were this but a temporary situation we would try to make the best of it, but in view of the fact that the need for rationing is more likely to increase than decrease, we find that we must adopt a new policy of doing business with our customers which will permit us to serve them well and at the same time maintain the records and comply with the rules and regulations of the O.P.A. Time is of the essence. It takes time to make out charge slips, to figure ration points on each, to post these slips, make out statements, mail them and later go over the statements with the customers in case of a question. With the exception of figuring points we have been performing these tasks willingly for the past 28 years in order that this store might offer a complete credit service to our customers. But the picture has now changed. Two of our bookkeepers are now devoting one-half of their time to waiting on trade, assembling orders and helping customers with their ration books. There is not enough time left in which to do all the normal bookkeeping. Were I able to help, I would gladly do so, but one-half of my time every day is spent outside the store trying to buy goods to sell. We are therefore going to eliminate one phase of duplicate bookkeeping by discontinuing monthly statements. Beginning January, 1945, no more monthly statements will be rendered. The sales slips given to customers at the time of purchase will be the only bills they will receive. And in view of this we are requesting that these slips be paid for on or before Monday of the week following the week in which the goods are purchased. It will be far easier for a customer to keep account of two, three or four slips and pay for them than to accumulate thirty or more until the end of the month before paying for them. Not only will this simplify our charge bookkeeping, but it will make the keeping of rationing accounts easier. It is not a little confusing for a customer to pay her ration points at one time and for the goods at another time.

When the war is over and ration points are out the window, the food merchant will be very happy to return to the only pleasant way of conducting a food store, and that is by giving a complete delivery and credit service. Until then we ask you to bear with us while we try to fill your needs to the best of our ability under the pressure with which we are now working.

Boston OPA Office Announces New Schedule

Boston, December 26—The Regional OPA Office today officially announced the exchanges in the food rationing program now in force.

Actions which became effective as of 12:01 a. m. Tuesday, Dec. 26 were:

1. Butter went from 20 to 24 points per pound.
2. The following eight vegetable items were added to the ration list:
Asparagus—No. 2 container10 points
Beans, green or wax10 points
Corn (vacuum packed, whole kernel) 12 oz. tin 20 points
Peas (exclude soaked dry peas)—No. 2 can10 points
Spinach—No. 2 can10 points
Home processed vegetables—any of the above—quart container, 2 lbs.20 points
Corn (except vacuum packed, whole kernel, exclude corn on cob)—No. 2 can20 points
Home processed tomato catsup or chili sauce—quart containers, 2 lbs. 60 points
3. Red stamps A-S through Z8 and A-5 through P-5 in Book Four were cancelled.
4. Blue stamps A-8 through Z-8 and A-5 through W-5 in Book Four were cancelled.
5. Sugar stamps 30, 31, 32, 33 and 40 for home canning in Book Four were cancelled along with all home canning certificates and coupons.

The OPA made the following announcements:

1. Five new red stamps, T-5 through X-5 will be validated Sunday, December 31.
2. Five new blue stamps, C-2 through G-2 will be validated Monday, January 1, 1945.
3. Values in both red and blue stamps will remain at 10 points each.
4. No new sugar stamp will be validated until Feb. 1.
5. Meat point changes go into effect at 12:01 a. m., Sunday, Dec. 31.
6. Changes in point values on canned or bottled fruits and tomato catsup or chili sauce, all reflecting downward ranges of from 10 to 20 points, go into effect at 12:01 a. m., Monday, Jan. 1, 1945.
7. Stamps now good are: Red stamps Q-5 through S-5. Blue stamps X-5 through Z-5, A-2 and B-2. All remain good for 10 points. Sugar stamp No. 34, good for five pounds.

ALL PERSONAL PROPERTY NOT EXPRESSLY EXEMPT FROM TAXATION is required to be listed under the items given on Form of List 2.

RESIDENTS need not include INTANGIBLE PERSONAL PROPERTY the income from which, if any, is included in a Massachusetts Income Tax Return filed in the same year.

NON-RESIDENTS, including certain foreign insurance companies, and foreign corporations which are engaged exclusively in interstate commerce, are NOT entitled to any exemption on account of TANGIBLE PERSONAL PROPERTY, which includes all MERCHANDISE, TOOLS, EQUIPMENT, FURNITURE AND FIXTURES.

Note:—A person is not entitled to any abatement of a tax on personal property unless a list is seasonably filed, except as provided in General Laws, Chapter 59, Section 61.

REAL ESTATE

ALL REAL ESTATE SUBJECT TO TAXATION in Andover on January 1, 1945.

Sworn statements which may be made by mortgagors or mortgagees under General Laws, Chapter 59, Section 34, must be filed on or before January 31, 1945.

Ask Frequent Practice In Safety Devices

Full cooperation between the police and fire departments, frequent practice in the use of safety devices, and a number of other recommendations are made by the Board of Selectmen in a comprehensive report released Thursday on the recent drowning tragedy in Ballardvale. The report of the Selectmen approves of the disciplinary action taken by the chief of the fire department, and it also urges an increase in the man power of the fire department, plus the purchase of under-water lighting equipment and, by implication, the purchase of a boat for drowning accidents.

The preamble of the report goes into considerable detail on the tragic accident, and states the specific charges upon which the disciplinary action was taken. The recommendations are as follows:

"Most investigations reveal weak points in organizations, and accidents emphasize the necessity of more and more safety equipment, and knowledge of its use. We believe our Safety Department can be improved in many ways, and we expect and insist upon the complete and immediate cooperation of all members of both departments. We have not had time to complete a study of all the ways in which our Safety Departments can be improved. We emphasize the follow-

An urgent appeal for nurses for the armed services was made today by Miss Mary E. G. Bliss, R. N., Chairman of the Massachusetts Committee for Nurses, Procurement and Assignment Service of the War Manpower Commission.

"Massachusetts has been given a quota of 969 nurses as its share of the 10,000 total needed immediately by the armed services," Miss Bliss stated. "This figure of 969 is larger than the total obtained in the entire year of 1944. The need for army nurses was apparent just a few days ago when it was revealed that hospital ships are returning to this country with no nurses in attendance, the need being so great for our nurses in the hospitals closer to the fighting fronts. Our men are fighting so valiantly on the battlefronts throughout the world are receiving the finest medical care in the world, but all the science and medical techniques will be of little avail unless these men can be given sufficient nursing."

"The German drive into Belgium has caused a large number of casualties which will shortly be reflected in an additional drain upon the nursing facilities in this country, and we must be ready to meet this emergency. The time has arrived when it is necessary for all of the nurses who have been classified by Procurement and Assignment Service of the War Manpower Commission as I-A, or those who have been temporarily deferred, and are now working in industry, public health agencies, hospitals, doctors' offices, or doing private duty to come forward and offer their services as Army nurses. They will be performing a great duty to the nation, but more particularly they will be instrumental in saving the lives of many of our fine young men in the armed services. Nurses wishing to enter the armed services who have been classified I-A, or who are now temporarily deferred, should report to their Red Cross recruiting station or to the First Service Command Headquarters, 808 Commonwealth Avenue, Boston, Mass.

ing points and will endeavor to see that they are carried out.

Recommendations

"1. We must have full co-operation between departments. Both Police and Fire Departments are members of one Safety Department, responsible to the Town of Andover.

"2. All members of each department must be made familiar with the use of safety devices.

"3. All safety devices must be placed in accessible spots, from which they can be quickly and efficiently taken to the scene of the accident.

"4. Officers in charge must assume command and responsibility in any emergency, and do it immediately.

"5. Regulations and practices of departments must be uniform and be understood by all members.

"6. Reports should not be based upon assumptions.

"7. A time-stamp record should be kept of all telephone calls in both Police and Fire Departments.

"8. Both Andover and Ballardvale Fire Departments should ring in alarm if there is any possibility that they may be needed.

"9. A member of one of the safety departments should remain at the scene of an accident until the work of both departments is completed.

"10. Regular and routine practice drills, including instruction in all safety devices, should be carried on in both departments.

"11. The Andover Fire Department should 'listen in' on all calls made to the Ballardvale Fire Station, and the Andover Police Department should do the same on all calls made to the police box in Shawsheen. Records of these calls should be kept on the time-stamp.

"12. The Log-Book and Ambulance Record in the Fire Department should be kept by the Officer-in-Charge.

"13. One or more boats must be kept in good condition and in readiness for drowning accidents.

"14. Equipment for under-water lighting should be purchased.

"15. We must increase the manpower in our Fire Department.

"The Board of Selectmen approves of the disciplinary action taken by the Chief of the Fire Department. We expect full co-operation from both departments in any suggestions made to increase the value of the departments to the town. In turn, we promise our assistance."

The chronological report on the accident reads as follows: "George Nicoll, fourteen year old son of Mr. and Mrs. James K. Nicoll of Clark road, Ballardvale, lost his life in the Shawsheen River shortly after

and Herbert Brown were on duty. Call Firemen Sanborn Caldwell and James Moore were also present at the station. The call was taken by Brown, who crossed the floor of the engine house and informed the Deputy Chief of the request. The Deputy Chief, who was upstairs in the 'loft,' did not respond to the call by taking charge, but remained upstairs and told Brown to have the police take the inhalator. In the meantime, MacKenzie went to the Police Station and reported the accident, advising the Chief that the ambulance was in Boston. Chief George A. Dane and Officers Deyermund and Gillespie were in the Police Station at the time. The Chief ordered Deyermund and Gillespie to go to the scene of the accident.

"Officer Gillespie drove the cruising car to a point opposite the side door on the west side of the Fire Station, a matter of traveling a very few feet. Neither police officer knew how to run the inhalator. When questioned, Fireman Brown advised that he also was unable to run the inhalator, which he and Caldwell had placed in the police car after Caldwell and Moore had taken it from its regular position in the station to a point about five feet inside the small west door. Some time was lost in this discussion, perhaps two minutes, then Officer Deyermund, who had previously walked over to the Fire Station, walked across the station and called to the Deputy, asking that someone be detailed to run the inhalator, and Fireman MacKenzie was ordered to do that work. MacKenzie then put on his coat, got in the cruiser, and at about 3:11 the

car started for the accident, about five minutes after the accident had been reported. At 3:16, the car radioed back to the Police Station. It was then between the Ballardvale railroad crossing and the Shawsheen River bridge, not more than a half-minute trip to the scene of the accident. Before its arrival the boy had disappeared.

"About three minutes after Mrs. Davidson called Andover, Michael Markesnis, a boy living on Marland street, and who had seen George Nicoll struggling in the water, called the Ballardvale Fire Station at about 3:08 or 3:09 and reported the accident to Howard Colbath, regular fireman then on duty. The only other person in the Ballardvale Fire Station was James Oldroyd, a retired call fireman. Colbath called Andover, and was told by MacKenzie to hold up, as the police were handling the case. Nothing further happened in the Ballardvale Station until Mrs. Davidson, who had first reported the accident, called up the Ballardvale Fire Station, between 3:11 and 3:12, and implored Colbath to hurry to the scene. Colbath called Andover again, was told to go ahead, and immediately started for the accident, accompanied by Oldroyd. They reached the Ballardvale crossing about 3:13, at which time the 2:30 train from Boston, officially reported as thirteen minutes late, held them up. The gate tender lifted the gate as soon as possible, and Colbath reached the spot just after the boy had gone under.

"The cruising car returned to Andover for grappling irons. Colbath returned to the Ballardvale Station

to get the service truck and went to Haggetts Pond for the steel boat customarily used in drowning accidents. The boy's father and uncle recovered the body at 4:30, and Officer Lynch, who had been summoned by Chief Dane, applied artificial respiration until the arrival of Dr. East. All efforts to revive the boy were unsuccessful.

"Our statement is based on reports from Chiefs Dane and Buchan, and on facts as we deduce them from a lengthy hearing held Saturday, December 23. Those present throughout the hearing were the boy's father, his uncle, Norman MacLeish, two more members of the boy's family, Town Counsel Walter C. Tomlinson, the Board of Selectmen, Chief George A. Dane of the Police Department and Chief Edward Buchan of the Fire Department. Evidence was heard from Mrs. George W. Davidson, Michael Markesnis, John W. Gollan, Chief George A. Dane, Officers Deyermund, Gillespie and Lynch, Deputy Chief Hilton, Firemen MacKenzie, Brown, Colbath, Madden and Murnane, Call Firemen Caldwell and Moore, and James Oldroyd.

"The evidence shows that the first call for help reached the Andover Fire Station at not later than 3:06. Help should have left within one minute, and timing shows that a car should have reached the scene of the accident not over five minutes later, or at 3:12. Not later than 3:09, the accident was reported to Colbath at Ballardvale. We are convinced that a call was made by Colbath to Andover, received by MacKenzie, and that MacKenzie told Colbath to 'hold up, the police are

taking care of it.' If Colbath had been told to go at once, he would have reached the accident about 3:11. In either case, it is possible that the tragedy could have been averted. The evidence shows that the Deputy Chief, although advised of the accident by Brown when the first telephone call was made, did not come down-stairs and take charge of the activities of the department, either at the first call at 3:05 or 3:06 or at any time before the cruising car left, not earlier than 3:11. Evidence also proves that MacKenzie held up the Ballardvale Department on his own responsibility, and wasted valuable time before proceeding to the cruising car and taking charge of the inhalator.

"Civil Service regulations in the Fire Department give the power of appointment to the Chief. This also places disciplinary action in his hands. We regret exceedingly that this accident occurred. We are insistent that immediate action take place."
