About three-quarters of a mile from the center of the town it might be developed into an area for recrea-







These requirements are estab lished and maintained for the good of the town and its residents; for the purpose of assessing the costs of normally accepted improvements against the land directly improved, rather than calling on all property owners of the town to pay, taxes, for the development of s cial land areas. This would be the case were unimproved streets to be accepted casually; because human nature is such that what suffices very well for a private way no long er satisfies the residents of a street once that street becomes an accepted street. Hence mediately demands would arise for water mains, sewer mains, drainag facilities, etc., were they not al-ready in place before acceptance. It is felt that the firm enforce

ment of these requirements results in a better town and in greate fairness to the majority of taxpay ers. At the same time it tends t reduce the number of half-hearter or dormant subdivisions, of which there have been so many in the past.







Police Ask Right To Register Bikes

In the interests of bicycle owners and as an aid to police the vo-ters at town meeting will be asked to accept an article relative to the registration of bicycles

Andover is the only community in this area that does not have bicycle registration. If the article is accepted it will give the police department the right to issue certificates of registration with the name of the applicant, his age, make of bicycle and the manufacturer's serial number.

A registration plate is then issued to be attached to the ve hicle. The fee is 25 cents and the registration is good for the life of bicycle or until it changes the hands.

Police Chief David L. Nicoll estimated that there are at least 2000 bicycles in use in town. About 25 are reported lost each year, many of which are found but some which are never claimed, The registration plate would enable police to contact the rightful own as soon as the vehicle is







Eye infections characterized by puffing and secretion, fever, aching muscles and other symptoms occur a week after eating the infected pork. No definite cure is known for the disease, but cortisone and the new hydrocortisone drugs have been successful in remedying the painful effects.
Super-cortisone such as Cotril have cleared the eye infections faster than any other drug, according to Tr. E. H. Steffensen of the Menry Ford Hospital. The new drug is also available in liquid form for injection into sore areas.




