

The town should spend \$844,-600 in the next 10 years to im-prove its water supply and distribution.

5500 Tax Bills Mailed, Income Up Over 1955

Some 5500 tax bills were mailed last weekend, according to Tax Collector James Christie. They were valued at \$1,314,-363.

Income from personal property taxes also is up over the 1955 value. Last year those taxes to-talled \$143,432.92 or \$21,599.12







State Cost Estimate Cole said William Black, rather than state director John Marshall, interviewed the committee. Black is quoted as estimating the construction cost of the school at \$753,000, compared with the es-timate of \$700,000 given at the school board meeting. However, the state's estimated total cost, Cole said, was less than the \$922,500 figured here. It did not include the \$25,000 allowance for sewerage or a ceptic tank system, he explained and would still be womewhat lower if that amount were added.

Attending the meeting were Cole, Secretary William A. Doher-ty, Supt. Edward I. Erickson and ty, Supt. Edward 1. Entered Fletcher Ashley of the Hugh Stubbins associates.

Plans Coming Soon

Plans Coming Soon Cole said the architects are planning to present the prelimi-nary plan here Aug. 7 at the reg-ular board meeting. Estimates based on that plan may be pre-sented at the same time, Cole added, which would give the com-mittee enough information to ask mittee enough information to ask for a special town meeting.

Sewer Decision No decision has yet been reached about the sewer problem although it was recently dis-cussed at a meeting of town of-ficials. Some have felt that a sewer connection should be supplied for the school, with the town paying directly for the in-stallation of the main. Others have maintained that the ceptic tank system should be installed as part of the school project, thereby getting state aid on that part of the work too.

Steel Strike Meanwhile, even as the plans progressed and the school com-mittee prepared itself to ask for a special meeting, the nation-wide steel strike threatened to enter



the picture. Officials have said there will certainly be a price increase because of the strike and its eventual settlement, which may drive the school's cost above







McKeon Is Scapegoat

We rather sympathize with Sgt. Matthew McKeon, the Marine now on trial because six recruits drowned during an after-dark forced march which he ordered.

While all of us are sorry for the families of the recruits, should we make Mckeon the scapegoat?

Many men who have served a hitch in the Marines will tell you that harsh training measures are nothing new to the Corps. That, in large part, is how the corps created its ability to fight better than most other groups of men. Marines are tough and have pride in their superior fighting ability, their ability to meet most emergency situations with credit to themselves and the country.

While we may not condone the harsh, strict measures taken at Marine recruit training centers, should we now punish Mckeon for taking measures - partly disciplinary, partly training - that have been the rule at Parris Island?

While it is not our custom to comment very often on affairs outside our own borders, we do believe that justice will not be done if the court martial finds McKeon guilty and sentences him to the brig and a less-thanhonorable discharge.

On only one point do we take issue - if McKeon is proven to have been under the influence of alcohol then he deserves to be punished. Not for the type of maneuver he ordered but because he could not, if under the influence, have commanded the recruits properly.

On the whole, we believe Mckeon is being made the scapegoat for policies long in effect. He should not be punished for only doing what others have done for many vears.

C.D. Is Valuable

Many men and women laugh aloud when they hear about Civil Defense activities - just another group of men and women playing games, they say.

And perhaps some of the CD activities may appear ludicrous, on the surface. But when anyone stops to think about the need for such an organization, they quickly abandon their grins of derision.

For, whether we ever have another war or not, the Civil Defense agency can do much good. Times of local emergency - storms, fires, floods - prove that trained personnel can play an active role in saving lives and property. We have seen it happen in towns surrounding Worcester when the tornado struck.

Other communities have seen Civil Defense take over when disaster hit - and become the only functioning agency within their borders.

Thus it is that we proudly compliment Director Hal Wennik and his hard-working personnel in creating an agency that may be of tremendous value some day.



WATER IMPROVEMENTS RECOMMENDED TO BPW

(Continued from Page One) Thus, voters will have to raise \$591,600 during the next 10 years if the entire program is to be fol-lowed as recommended, after deducting appropriated funds from the total project cost. Monday night's BPW meeting

heard Joseph Lawler of the engineering firm explain the report and agree to furnish the board his company's proposal for drawing specifications and supervising construction. Action on the initial stages of the program will be held up until the proposals are re-

This Year's Work

The firm's recommended course of action this year would have the town spend appropriated funds this way:

Two welded steel storage tanks, one of 800,000 gallons capacity at \$57,000 and the other, a one-million gallon tank, cost-ing \$75,000;

Special pump controls for Ban-croft rd. station, \$1000;

Improvement to Haggett's pond pumping station, \$28,500; New mains in the west side high service system, \$91,500.

Estimates Purposely High

"You'll have money left over", Lawler emphasized. He explained that 20 percent contingencies and fees have been added to the es-timated costs - which even then total only the appropriated amount of \$253,000.

He particularly urged hurry-up action on the steel tanks in view of the nation-wide steel strike. It will take nearly a year to get delivery if the contracts are awarded in the immediate future, he pointed out. Other parts of the program urged for this year can be started somewhat less quickly, he said. New Mains

The new mains listed for 1956 installation include 1500 feet of 16 inch pipe along the road on Wood hill from new storage tank to Haggett's Pond rd., \$23,000;

Twelve-inch main for 700 feet on Lowell st. from pumping station to 10-inch cross-country line, re-placing 10 inch main now there, \$7300;

River rd. main for 2400 feet, Cross rd. to Chandler rd., 12-inch replacing eight-inch pipe, \$27.500:

Eight-inch main for 1600 feet along Chandler rd. from River rd. to Brundrett ave., replacing six-inch pipe, \$9000; Eight-inch main along Ledge rd.

from Chandler to Greenwood rd., no pipe now, \$8500; Nine-hundred feet along Green-wood rd, from Chandler rd, to

North st., eight-inch main where none now exists, \$6300;

An eight-inch main for 1400 feet on Beacon st. from present six-inch main to Chandler rd., none there now, \$9000. The remainder of the initial program - slated for action with-

in West Andover to improve the system there.

Second Stage Plan

THURSDAY

The second-stage program in West Andover - to be finished in five to 10 years would cost \$275,800 - with \$128,100 listed for major pumping station improve-ments and \$147,700 for further improvements to the distribution

In that same period of time, second-stage recommendations for the high service system place the cost at \$133,400 for distribution mains

Lawler warned board members, however, that a water supply study should be completed before the second stage recommenda-tions are definitely approved -for some changes might result if new water supply areas are lo-cated. At least six months should be allowed for that study, he said, including test pumping for some weeks in any new site. That is done only briefly if the water is pure and potable but may con-tinue longer if there are experiments to be run on clearing any disagreeable taste in the water.

Lawler told the board that stage three in the proposals -with no cost estimates attached should be completed as the need arises. It includes a second stor-age tank in West Andover, added distribution mains; more mains in the high pressure system and re-placing the present open distribution reservoir with a covered tank.






