Charter Study Group Seeks More Latitude

The town manager study committee met for the first time Tuesday night - and promptly decided to ask the Selectmen's permission to broaden the scope of the study.

Harris N. Sanfilippo, newly-designated chairman, will discuss the subject with the Selectmen, who have set the ground rules for the study.

Nearly all of Tuesday's meeting was concerned with members' feelings that the study could not accomplish much unless departmental functions, and inevitably personalities, are discussed. The original charge from the Selectmen asked that these subjects be avoided.

There was general understanding at the session that the purpose of the group is to see whether the town manager charter is functioning as intended, and if not, to determine whether the charter can be strengthened or whether the fault lies in the implementation of the document.

Members of the Committee promptly decided that this can not

be done unless there is some investigation of departmental functions, to see whether these conform to the original intent of the charter.

Mr. Sanfilippo emphasized on numerous occasions that the Committee must maintain objectivity in its study.

He agreed with one member that it is possible for the Committee to recommend changes, even to a different form of charter, if this is believed necessary. But he also pointed out that there should be no prior judgment that problems exist.

As far as personalities were concerned, members emphasized that a study of departments will necessarily include observations on individuals.

But Mr. Sanfilippo stressed that the competency of any individual is not to be determined - this, he said, should be determined by the individual's superiors, and handled through normal department routine.

One of the key reasons for

Regional Committee Set On West Andover

New Code For Mail

The Post Office's answer to speedy and correct mail delivery all over the country goes into effect July 1 - but you've got to memorize a few numerals to use it.

Postmaster Francis J. Mooney announces that Andover's ZIP code is 018 - plus the digits 10 for every patron who has mail delivered from the office, and 11 for those getting mail via the Shaw-sheen branch, Ballardvale's code - that's a separate Postoffice - is 01820.

The theory behind the new code is that nation-wide usage will allow speedier delivery, and cut mistakes to a minimum.

Mr. Mooney insisted, while outlining the new procedures, that the effectiveness depends on everyone remembering to use the code.

A correct address will have, following the normal sequence of words, the full numerical code.

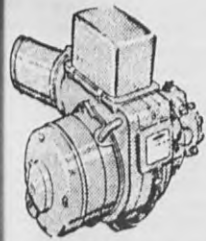
Their attendance is sponsored jointly by Post 8 and the Andover Service Club.

Dr. Glidden Was Honored

During the Commencement Ceremonies of Tufts University in Medford, Dr. H. Spencer Glidden, 67 Cheever cir., was honored by receiving the Distinguished Service Award and Citation given annually by the Alumni Association of the University.

This is the highest honor which can be granted by the Alumni Association and was awarded in recognition of Dr. Glidden's many years of service to the University. Since 1932, he has taught in the Department of Pathology of the Medical, Dental, and Postgraduate Schools, rising to the rank of associate professor. He served as chairman of the Alumni Council in 1960 and as chairman of the Alumni Fund Committee in 1961.

There was considerable discussion of the work the Committee has before it, and the exact purpose for which it was created.

It appeared to be generally agreed that the word "functioning" in the Selectmen's charge to the Committee is the key - that it is to be determined how the government is functioning in reference to the charter, and the intent to the voters when they approved it. Areas of misunderstanding, by people, or unclear language in the document, can be cleared up, the Committee felt.

It was obvious that there will be serious thought given to the charter as a whole in relation to what is being done in practice.

Members pointed out that the charter is just a document and that people implement it. Some reference was made to a discussion between Committee member Henry Wolfson and the Selectmen a number of months ago, when Town Manager Thomas E. Duff explained that the separation of authority specified in the charter is not followed. The charter says the Selectmen in the role of policymakers and the manager as administrator. Cahill, campaign vice chairman, Lawrence postmaster and former special agent of the Federal Bureau of Investigation.

Ground Broken For Construction

Ground breaking took place last Friday for Lawrence General Hospital's \$3.5 million building program that calls for \$1.5 million in voluntary contributions, the community's largest fund raising effort for a non profit institution organized 88 years ago for "care of children of working women, and Hospital for the needy".

A new seven-story Hospital wing will provide space for 120 new patient beds, bringing the total to 300, six major operating rooms, kitchen and dining departments, laundry, and other needed facilities for a Hospital patient area comprising Andover, Lawrence, Methuen, North Andover and Salem, New Hampshire.

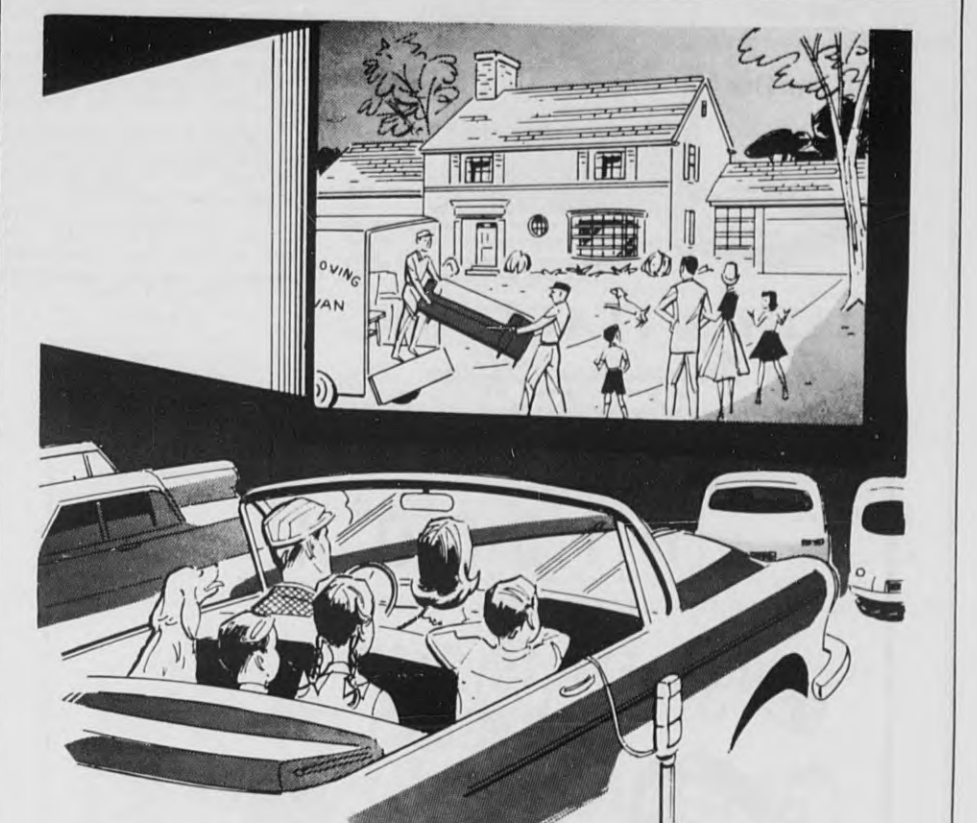

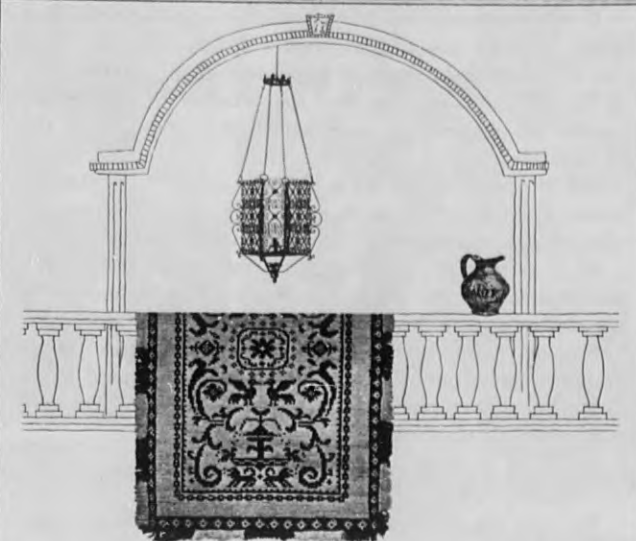

EDITORIAL THOUGHTS

Whole Town Grows

In recent months we have heard the suggestion that all areas of town government should put building needs in the background, because of required school construction.

To be sure, we can see the wisdom of planning to spread out construction over a number of years, when this is possible.

But it occurs to us, as it must to others, that the very reasons which compel us to embark on school construction also require expanded facilities throughout the town.

So it is virtually impossible to let all other municipal construction go by, while concentrating on schools. The population growth demands so many other town services.

Rather, we foresee increasing responsibility for the capital expenditures committee, recently appointed by the Selectmen. That group could schedule the projects, with some over-all objectivity.

Lingering Doubt

We view the probability of having the vocational school within the town borders with mixed feelings.

All that has been said about the advantages of the school to the area is true. And probably the site on River rd., across from North st., is one of the best available.

Yet there is a lingering doubt in our minds as to the ultimate benefit of removing real estate from taxation, as will be the result in this case.

We have also wondered some about placing the school in an area where close to 100 percent of the students must be transported. There is no public transportation to the area. About five percent of the students will come from Andover, leaving 95 percent of the enrollment for Lawrence, Methuen and North Andover. Obviously transportation must be provided, and this could be an increasing annual burden.

The Regional School Committee has the authority to acquire a site, without consultation with the communities. It is reported that 11 sites have been studied, and the River rd. area has been chosen. So there's little to be gained in terms of a review of the site.

But we'll always wonder whether or not, from the Andover view point, this is the wisest course of action.

Protection From Bikes

A few weeks ago, one of our readers suggested that children on bicycles be prevented from riding helter-skelter along Main st., during the course of the Memorial Day parade.

We have another one to add.

Last weekend's Sidewalk Bazaar was a real success; the crowds were dense, and the street was full of pedestrians.

Yet many children - some appearing to be teen-agers and others a few years younger - zipped through the crowd on their bikes. They disregarded the safety of pedestrians, by weaving through the crowds and up and down the street.

The young people who have so little regard for the rights of people on foot should be, in some way, taught that their actions are wrong. Certainly the police can't patrol such an event sufficiently to keep wild bicycle riders under control, there aren't enough men for that.

Perhaps it comes down to the issuance of an official ultimatum that bicycles may not be ridden on the town streets, if their owners do not show sufficient care for others. One way or another, the relatively few children who ride this way must be brought under control.

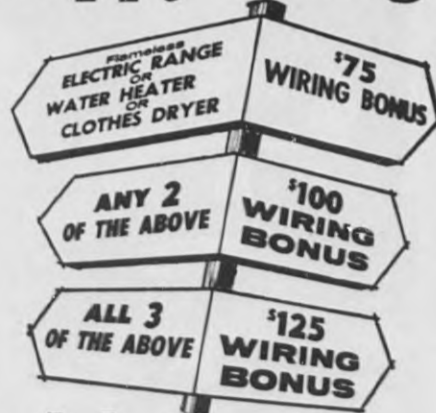
