For the 1996-97 school year, with a seven-period schedule, teachers taught 619 hours per year. For 2008-09 school year, teachers taught 621 hours per year.

Twenty percent of current AHS teachers have never taught classes in a 45-minute schedule, said Hajdukiewicz, and for those who have, many years have passed.

The 12 full-time positions cut would be teachers with the fewest amount of years in the district, she noted.



## Get ready for wild, wide open races

There are crowded fields for Andover's state senate seat, and for its two represenative slots.

Susan Tucker, 65, D-Andover, Andover's senator since 1999, announced earlier this month she will not seek re-election in the 2nd Essex and Middlesex district, setting the stage for a wild race.

There are already nine candidates for the position, including a half dozen from Andover. The last time there was even a contested race for this senate seat was in 2004

Barry Finegold is one of the senate hopefuls and his attempt will leave his 17th Essex representative seat open. Two Republicans from Andover have pulled papers to

earn the spot.

Andover's other state represen-Andover residents may see more tative, Barbara L'Italien, vice-chair of House Committee on Ways and Means, will be the only incumbent on the town ballot at state primaries on Sept. 14. Her district, the 18th Essex, includes portions of Andover, Haverhill, Boxford, Georgetown, Methuen and North Andover. Three other Andover residents, all Republicans, have declared they will challenge for the seat.

> Candidates for state representative must collect 150 signatures; state senatorial candidates must collect 300. Papers, with signatures must be returned by April 27 to their city or town board of registrar of voters and brought to the state by May 25.

State primaries will be held Tuesday, Sept. 14 and the general election on Tuesday, Nov. 2.

chance to take to the streets to support the troops on Saturday, April 17. An Andover man has planned a free 4-mile walk or run, with any money donated helping to build homes for troops who return home from the war on terrorism disabled.

While the race itself is free, any money voluntarily offered will go to Homes for Our Troops, a national charity that builds specially adapted homes and gives them to new disabled veterans returning home from Iraq and Afghanistan.

The reason the race is free is, in today's economy, those people who can give, I hope they do. And those that can't, I hope they can participate," said race organizer Bill Pennington, of Clark Road.

"It's almost more about the exposure than about if we collect \$2,000 or \$200," he said. "For the people who came back and who are physically able

to [participate], and people who cannot, it's to show them people in the United States do care.'

Pennington became involved with Homes for Our Troops last year when Andover resident Jay French hosted a local fundraiser to help build a home for Sgt. Peter Rooney, who lost both legs when his vehicle hit a roadside bomb in Ramadi, Iraq. The home has since been dedicated, said Pennington.

When Pennington tells business owners about the April 17 race event, they often can't do enough for him, donating their time or supplies, he said.

"I have not been able to pay for anything," he said.

The Massachusetts School of Law in Andover has donated 500 T-shirts, which will be given free to participants.


"We want people to participate and come out, whether you can give 2 cents or something more," he said.

River levels expected to crest Wednesday night into Thursday, April 1.

At 8 a.m. on Wednesday, March 31, a Wilmington gauge of the Shawsheen River measured 9.26 feet, more than two feet over flood stage.

High Plain Road, notorious for flooding, was closed on Wednesday morning, as well as route 28 at the North Reading town line.

However, as of Wednesday morning, police lieutenant Harry Collins said he was not aware of any residents, including the Washington Park condominiums, that were being evacuated by flood waters.

Rain-induced flooding prompted officials to close Ballardvale Road from Sunset Rock Road to Enfield Drive on Tuesday night, but it was reopened Wednesday.

On Monday night, March 29, the Massachusetts Emergency Management Agency activated its State Emergency Operations Center, with personnel working around the clock in Framingham in response to the rain. The head of the U.S. Department of Homeland Security's Federal Emergency Management Agency announced The National Weather Service Essex County residents (and resiissued a flood warning for Andover dents of sox other counties) are to start the week, with Shawsheen eligible for federal disaster aid.

School Committee members David Birnbach and Dennis Forgue cast votes against a March cuit breaker (\$2,366,078) 30 motion that approved Superintendent Claudia Bach's recommended budget of \$63,779,211 for fiscal year 2011. Town Manager Buzz Stapczynski's recommended total for the schools is \$61.078.014.

Bach has suggested the following as ways to decrease the gap: increased class sizes in the foreign language in the middle schools and dropping block scheduling at Andover High School ideas hat are fiercely opposed by some parents and staff.

"I feel comfortable with the superintendent's number, knowing we're going to work backwards from there," said Paula Colby-Clements, newly elected member of the committee. "The options (budget cuts) presented just aren't palatable to me ... There's a lot of things we can look at, need to look at."







## 'Impressions' closes Andover Chamber Music season

Now completing its 13th season of bringing thematic chamber music concerts to the Merrimack Valley, Andover Chamber Music will present its this season's final concert, "Impressions," on Sunday, April 11, at 4 pm at the West Parish Church in Andover.

'Julie Scolnik, artistic director and flutist, is always on the lookout for beautiful, little-known works to introduce to her audiences, and this program of music for flute, harp and strings is no exception," says a release from the organization.

Franziska Huhn, the first harpist ever to receive the coveted artists' diploma from the New England Conservatory, is featured in this concert, as well as three dynamic string players from New York: violist Dov Scheindlin, cellist Mina Smith, and violinist Katherine Fong.

The concert includes music from the relatively unknown French composer, Jean Cras, with what ACMS calls his his beguiling Quintet for flute, harp, and string trio.

Claude Debussy, one of the leading composers of the Impressionistic music movement in France, described his languid Sonata for flute, viola and harp as "terribly melancholy--should one laugh or cry? Perhaps both at the same time?"

Introduction and Allegro, written by Maurice Ravel for woodwinds, harp and strings, was a commission which coincided with the release and sale of the new pedal harp, and was composed, though quickly, during the most artistically productive period of Ravel's life. "Like the Cras [piece], it contrasts three quite different sonorities, with haunting wood harmonies, impressive harp cadenzas, and beautiful string quartet writing, and yet the end result is so vorsen after Keyboard Suite program.

A couple of my colleagues at the high school have been doing research on how misconceptions affect learning and understanding, and how they can be difficult to extricate from our minds. The oceanography teacher cited how the Coriolis Effect, which explains how the earth's rotation affects oceanic and atmospheric currents, often becomes associated with a popular misconception. Many believe this effect also causes draining toilet or sink water to circulate in opposite directions in opposite hemispheres of our planet. According to the oceanography teacher, this misconception is very resistant to delete from students' thinking, even after repeated lessons disproving it.

None of these would improve education in Andover. The Spanish national newspaper (El Pais.com) published an article March 26 in which the results of a study of bilingual and monolingual students were presented. The results, for those of us who use more than one language, were not surprising. The bilingual Spanish/English students, all native speakers of Spanish, know their first language better than those who speak only Spanish. The biology of the brain is altered in bilingual people. They exhibit greater bi-lateralization of the brain, develop markedly superior analytical ability, and demonstrate heightened meta-linguistic awareness. If the results of this study conducted by Spain's Ministry of Education and the British Council are to be believed, we should be expanding our world language program to begin earlier, rather than eliminating what is already a tardy introduction. If we were to begin teaching a second language in the elementary schools, this would preclude eradication of the middle school language program. What is more, it would greatly increase second language learning at all levels. In fact, after students have acquired two languages, the third and fourth are more easily accessible. Finally, the way to allow students to pursue a fully bilingual education, with subjects like math, social studies and the sciences taught in two or more languages, is best suited to the block schedule. Perhaps, we could then consider dividing the high school into several bilingual 'houses.' With the 21st century in full swing, the thought of increased numbers of students in the classroom, in a wholly monolingual environment, studying in rapidfire 45 minute segments does not seem to be the best way to educate the children of Andover.

If one does not "understand why teachers should be any different, or why they would want to be different" (Steven Schwartz, MD, "Teachers should be evaluated on merit." Townsman). then it is best to make attempts to understand before misconceptions set in. In the case of Schwartz' letter, there appeared a misconception about teacher performance and compensation: "To my knowledge, teaching is the only profession in which evaluation and performance are not tied to compensation."

All members of the Andover Education Association work under a bilaterally negotiated contract that contains explicit language concerning evaluation, performance, and compensation. The teacher evaluation model is based on extensive research on effective teaching and uses multiple criteria to assess pedagogical competencies and deficiencies. All teachers must be evaluated every one to two years, recertify with the State DESE every five, and be periodically involved in continuing education to move ahead in the salary scale. The contract explains the due process exercised in the case of substandard teaching performance.

I agree with Dr. Schwartz that "most professionals would be eager to be evaluated on merit." And that is why there are high caliber professional teachers throughout the Andover School System who merit educating our students to reach their full potentials.

#### Editor, Townsman:

One of the items on the School Committee chopping block in the latest attempt to close the budget gap in Andover is the block schedule at Andover High School. For those unfamiliar with the system, this means abandoning the four 82-minute classes in a two-semester year for the more traditional 7-period, 45-minute, yearlong classes. Here's what's missing from this conversation: any real discussion of what happens in an Andover High School classroom.

I'd like to show you my ninth grade English class, currently reading Romeo and Juliet. Today's question: Is the younger generation obligated to take up the causes of their parents? Students will write independently on this for 10 minutes. Another 10 minutes will be spent discussing, challenging, questioning. We now pick up Shakespeare's text and begin our exploration for the day related to their writing question. It will take at least 5 minutes to explain their task, call out their groups, move into their groups and begin their work. This involved me during preparation time selecting passages to read closely, making groups, and writing up and copying an assignment sheet. While they find the relevant dialog in their given scenes, I work with different groups, occasionally re-directing conversations, suggesting passages, and asking questions.

This is an opportunity to connect with kids on a more personal level. For 25 minutes they read, interpret, misunderstand, clarify and work toward the assigned product, a visual piece that will include imagery from magazine cutouts and text selected from the play that demonstrates a theme relating to our essential question. Preparation for this included procuring magazines, scissors, glue sticks, poster board, and markers.

#### Proposed school cuts are unwise, says teacher

#### Editor, Townsman:

Recently the school administration announced it would recommend increasing elementary class sizes, cutting the middle school foreign language program, and moving the high school to a seven-period day. These proposals are not educationally sound, but are simply sacrifices meant to meet budget restraints. Education proposals should not be about sacrifice, but about identifying priorities and committing to them. The school administration's proposals were not devised with the contribution of the Andover faculty and its educational expertise, or with the input of concerned parents. I encourage this community to imagine alternatives to these cuts, alternatives that will mend the harm of past cuts and forge improved opportunities for Andover children. Is going back to outdated ideas going to help our students? Sacrificing the learning experiences of your community's children hardly seems wise.

As a high school social studies teacher here in Andover I am aware that many of my students approach current events with a blasé attitude based on the idea that "that's the way it's always been, we just have to accept it." Yet when studying feudalism, absolute monarchies or totalitarianism, many students react with outrage that people would put up with such inequality and injustice, even temporarily. This long view of history allows these same students to review their stance on contemporary issues, many of whom suggest that there currently could be a better way of doing things in regards to many policies. They see that modern democracies are superior to the static oligarchies of the past, but they remain astounded by some of the priorities of their representatives at every level. 

## Mike Dalton, rest in peace **Bill Dalton**



## Animal welfare group helps families feed pets

The Coalition to Protect Animals Locally, a non-profit, local organization whose mission is to support animals, has been donating pet food to organizations like Neighbors in Need, which operates seven food pantries in the Merrimack Valley and feeds over 500 families a week.

After being contacted by Andover's Linda Zimmerman, executive director of NIN, and told that CoPAL's prior two pet food donations were almost all gone, volunteers from CoPAL loaded up their minivan and on March 24 contributed more than another 600 pounds of pet food.

Statistics show that almost two-thirds of Massachusetts' residents have at least one pet, according to CoPAL's Lois Karfunkel. Over the past two years, according to the MSPCA, there has been a 110 percent increase in the number of pet owners who state that financial reasons caused them to surrender their family pets. To address these issues, CoPAL initiated its "Keeping Families Together" program to help families pay for items such as pet food.

CoPAL will hold its next meeting on Thursday, April 8, at Enterprise Bank in downtown Andover.

While the informal working meeting will run from noon to 2 p.m., volunteers are welcome to come for whatever time they may have available. At the meeting, the group will address CoPAL's Keeping Families Together pet food bank project, the extension of donated pet food to senior citizens, an upcoming Humane Education training day, an on-going cable TV project, current legislation affecting animal welfare, and other projects CoPAL has undertaken.

#### 50 Years Ago March 31, 1960

A nationally known corporation that owns and operates several golf clubs across the country is vitally interested in developing a 27-hole course in west Andover. If present plans materialize, a club house valued at about \$750,000 would be constructed. There will be swimming pools, tennis, and other activities designed for youngsters. Nine of the 27 holes would be for women.

Twenty-two merchants gathered at an early morning meeting Wednesday voted unanimously in favor of reverting to penny parking (from one nickel). A change will cost about \$2 per meter from the current five-cent meters installed in 1957. The amount of money collected from the meters has not changed much since the change.





## Calling for a parent coach center Ken Seifert



became an elementary principal in upstate New York, I was a developmental reading teacher K-8. The

Before I

major tasks were how to become an effective reader, critical thinking skills and how to study. I was, in effect, a coach.

While talking to a group of parents about my life before principal, they took particular interest in the coaching concept. Next thing I knew, the PTA president listed a preschool session for parents interested in "coaching your child to read." About a dozen people showed up.

For the first half of the meeting we discussed academic skills such as recall, comprehension, intent of the author and reading for a purpose. We agreed to have another meeting to elaborate on any and all of those items. I introduced the notion that, by using the book in your lap, there were ways to open your child's mind. I emphasized the importance of having children enjoy the world of books and how the early experiences can turn, on or off, how a child feels about books in later life. One of the most significant tools for the coach is to create an environment that fosters two-way open communication between parent and child. The sooner such a process is established the greater the trust and understanding will exist between the two. I then set the stage. You could be sitting with your child in your lap with his favorite book. Your daughter could be next to you with your arm wrapped around her with a new book. It is a calm and tender time for both of you. If you ever have a chance to communicate or share, it is such a moment. It is one of the best ways a parent can discover what ideas and explanations a child is using to interpret the world around him. It is not an opportunity to dispense advice, judgment, or to steer the conversation in the direction you would like it to go. It is a time to find out the book your child sees and is writing in his mind. Depending on the book, you can use it as a vehicle to ask a variety of questions and share ideas. In no particular order, here are some questions parents can ask children, geared to a variety of stories: ■ What character would you like to be in the story? Why? Who is your favorite character?

■ I can think of another way of saying what he said. What would you say?

■ Is this confusing to you?

■ Diego went to the top of the mountain, where would you like to go? Who would you take with you?

■ Do you think what he did was right or wrong? Why do you think so? What would you do to a bully?

■ Would you end the story in a different way?

■ If you could be anywhere in the world this minute where would you like to be?

■ How can we make things better? If you could change one thing what would it be?

■ When you worry what do you think about?

I shared some of these questions that evening and ideas began to flow. It dawned on me – parents helping parents is an underutilized asset.

The situation is different today. We can actually do more today than we did years ago, back when my mom and dad were coaching seven Seifert kids. Technology can be used to show actual situations with parents coaching as a good coach would. Video, community TV, and the Internet can help accumulate all kinds of information.

I envision such a partnership between home and school where parents can become head coaches, assistant coaches, trainers and advisors as the child progresses. We can share our collective experiences and place them in the coach's corner of a Parent Center so others can have the benefit of those before them.

What do you think? Any one wish to participate in the making of a Parent Coach Center? The idea of parents helping parents has huge potential. If you have an interest, please let me know. In the meantime, I am going to make a few calls in the area and see if we can get some partnerships going.
